



# FEE STRUCTURE 2011-2012

Classification and fees are determined by the average of your gross seed and seed treatment sales for the past three years.

## 1. Active Members

Active Members are Individuals, firms, research institutions and corporations and bona fide divisions of corporations whose primary business is dealing in or selling seed and associated plant technologies delivered in or on the seed. Each Active Member shall be entitled to one vote on all Corporation affairs. Active Members shall enjoy the full privileges of the Corporation. In the general sessions, Active Members must appoint one member or officer of the firm, corporation, or division as its representative, and that person exercises the member's one vote. In committee meetings, only one representative of a company may vote.

### (i) Canadian Members

Sales of wholly-owned or partially owned affiliates are to be included in the three-year average gross seed sales. Otherwise, affiliates must apply for their own memberships.

\* If your company qualifies for more than one category (e.g. gross sales plus broker), the category with the largest annual dues is payable.

## 2. Associate Members **\$2,100**

Associate members are wholesalers and other companies marketing seed-related products or services. Associate Members shall have no voting rights, shall not be eligible to hold office in the Corporation, and shall not be eligible to attend meetings declared to be executive sessions. Associate members can serve on committee executives and are encouraged to do so. In other respects they shall be entitled to all privileges of the Corporation.

## 3. Affiliate Members **\$1,208**

Affiliate members represent any regional, provincial, national or international association of seedsmen or seed dealers. Affiliate Members shall have no voting rights, shall not be eligible to hold office in the Corporation, and shall not be eligible to attend meetings declared to be executive sessions. Affiliate members can serve on committee executives and are encouraged to do so. In other respects they shall be entitled to all privileges of the Corporation..
